Position: Licenses and appointed teachers working in District 24 schools for NYSIP Grant

Location: Various locations in schools in District and offices in Queens along with remote

Eligibility Requirements: License and appointed teachers who currently work in District 24

Selection Criteria:

- Teachers working in District 24 schools with at least (3) years of satisfactory experience
- Demonstrated ability in developing and implementing Career Day and/or College and Career Readiness (CCR) related events to support students and families
- Ability to collaborate with school leaders, family-facing staff, and ideally, community-based organizations, to support students and families
- Able to communicate and work well with colleagues using collaborative software (e.g., Teams, Zoom)
- Experience with implementing (in-person and remote) career day activities/events and student and family-community engagement events for the school community
- Strong written and verbal skills
- Understand the Chancellor's priority on Equity in Education
- Must be willing to collaborate, develop, and share best practices and all documents related to Career Day and/or College and Career Readiness (CCR) related events with an attention to details that supports replication
- Preference will be given to teachers from D24 schools who can demonstrate proven record of implementing successful Career Days and CCR related events.

Duties and Responsibilities:

- Utilizing existing, and/or developing, practices and documents that support replication of Career Day and College and Career Readiness related events to create a D24 Career Day Guide
- Commitment to attend all related NYSIP grant working sessions
- Attend and actively engage in working sessions offered through NYSIP grant around creation of a D24 Career Day Guide
- Identify, develop, and organize materials to develop the D24 Career Day Guide
- Work with various educators and turnkey, if needed, implementation of D24 Career Day Guide to others
- Utilize DOE resources to support initiative including Diversity and Equity for All initiatives
- Support development of reports, spreadsheets, web pages and other digital documents to be used by grant to identify impact
